Student Code of Conduct

At Calrossy Anglican School we believe in fostering an environment based on love and respect, where every student can grow holistically, learning and serving in our unique environment. Our Student Code is built upon the principles of love, kindness, and mutual respect, guiding us towards creating a community culture that reflects these values, built on the teachings of Jesus. By adhering to this Code, we commit ourselves to nurturing a positive and supportive learning environment in which everyone is valued, included and important.

Preface

The aim of this Code is to outline the standards of behaviour expected of all students of the School. This Code does not provide a detailed and exhaustive list of what to do in every aspect. Instead, it sets out general expectations of the standards of behaviour required.

The Code places an obligation on all students to take responsibility for their own conduct and to work with peers cooperatively to achieve a consultative and collaborative school where students are safe, supported and engaged, promoting a strong sense of belonging.

At Calrossy Anglican School, all students and members of staff are bound by our Mission and Vision and are expected to interact with each other abiding by these values and conduct themselves responsibly daily.

This Code applies equally to all students; day, boarding and eCalrossy students.

Students are required to have high standards of behaviour and:

- a) abide by the School Rules and Student Code as they apply from time to time,
- b) behave courteously and considerately to each other and to staff at all times,
- c) not do anything in any activity which may bring the School into disrepute, including in print and electronic media,
- d) support the ethos, goals and values of the School,
- e) attend and, if required, participate in assemblies, sports programs, compulsory school events such as Presentation Day or other events determined by the Principal, including camps and excursions that are an integral part of the School curriculum. This includes attendance at Chapel and Christian Studies lessons for Day and Boarding students and Christian devotions for eCalrossy students,
- f) wear the School uniform as prescribed, including when travelling to and from school and follow conventional standards of appearance while at school and externally in accordance with the School's guidelines and the expectation of the School community,
- g) attend the School during school and residential hours (or join the eCalrossy lessons), except in the case of sickness or where leave has been given or an exemption from attendance has been granted.

All interactions and behaviours are expected to be in line with the Calrossy values: Selflessness, Integrity, Resilience, Inclusiveness.

It is the responsibility of all students to adhere to the expectations of the School. Inappropriate behaviour will be met with appropriate consequences.

Breaches to this Code may result in consequences that will vary based on the age and stage of the student(s), the severity of the offence, the impact on learning and or rights of other members of community. Responses may include but are not limited to: student reflection, lunchtime or after school detentions, community service, withdrawal of privilege, restorative meetings and collaborative reflection. More serious offences or repeated infringements could result in withdrawal from class, School Suspension or Expulsion.

At no time will corporal punishment be used at Calrossy Anglican School. The School does not explicitly or implicitly sanction the administering of corporal punishment by non-school persons, including parents, to enforce discipline at the School. The use of any form of corporal punishment by a staff member, including volunteers and contractors is strictly prohibited.
